#### SERVICE OF NOTICES

Notices may be served by certified mail or applicant may personally serve notices.

If applicant intends to serve notices personally rather than by certified mail, applicant must comply with the following requirements:

- 1. Leaving the notice in a mailbox is **illegal** and does not constitute valid service.
- 2. The notice must be personally handed to one of the property owners. Leaving the notice at the door is **not valid**. (If notice is hand delivered in lieu of certified mail, the owner or owners of the property must place their signature(s) along with the date next to their names. If the property is owned by more than one person, signatures with dates will be required from all owners.)
- 3. The notice must be hand delivered at least ten (10) days before the meeting date.

If an applicant is unable to hand deliver to a property owner, the notice should be mailed certified immediately to meet the ten day notice requirement.

Land Development Application Notices- Chapter 245, P.L. 1991 (N.J.S.A.) (40:55D-12(H)

As of August 7, 1991, the above referenced law became effective to require an applicant seeking approval <u>of a major</u> <u>subdivision or site plan</u> to provide notice of a public hearing to all public utilities and cable TV companies that own land or possess an easement within 200 feet of the proposed development.

Below is a list of public utilities operating in Medford Township. Notice to public and local utilities are required for any development application, if these utilities possess easements in the Township and are registered with Medford Township.
