Neighborhood Services Advisory

Township officials in the Utilities Division are advising residents who have sanitary sewer service to watch what is being flushed down the drain. Advertised "flushable wipes" aren't so flushable. Staff have responded to a number of sewer backups caused by personal care and cleaning wipes, and the Township is urging residents not to flush these wipes down their toilets.

The wipes can catch on small pieces of the sewer pipe and lead to big problems. If it's not the small piece of the pipe it could be a root or something similar inside or some other foreign matter that starts a build-up. The first wipe catches and then the second wipe and pretty soon as they gather it becomes a large ball of wipes. The inevitable is that the entire pipe becomes plugged with a ball of wipes.

It can cost thousands of dollars per incident to get sewers unclogged, and it's being paid for by your water and sewer bill revenue. This repetitive type of incident could potentially restrict the Utilities Division's ability to invest in new sewer mains or rehabilitation of other parts of the system that should be replaced or refurbished due to age and wear.

Wipes aren't the only item that crews have had to pull out of sewer lines. Diapers, feminine hygiene products and even clothing items have been found to clog sewer lines.

As a reminder to all residents, only toilet paper and human waste should be flushed. Wipes, diapers, etc. should always be disposed of in a trash can.



2022 SPRING BRUSH COLLECTION PROGRAM

Below are the collection dates for the annual spring brush collection in the Township:

Zone 5: Week of April 4
Zone 4: Week of April 18
Zone 2: Week of May 2
Zone 1: Week of May 16
Zone 3: Week of May 30

The Neighborhood Services Department will alert the public via Nixle alerts and Facebook posts as they complete each Zone or if they experience delays. Each street will be collected once. Township Code states "All brush shall be stored on a resident's property and shall not be placed at the roadside earlier than 10 days preceding the Monday of the scheduled collection week". Brush placed at the street for collection outside of these collection dates will not be collected.

Brush shall include the pruning of trees, shrubs, bushes or vines, but exclude grass clippings, flowers, weeks, tree trunks, stumps and leaves. If the excluded items are mixed with the brush, the material will not be collected.

All brush must be piled neatly at the edge of the property and cannot be placed in any roadway or sidewalk. Brush should not exceed 4-6 feet in length, and should not be any larger than 6 inches in diameter. As a reminder for those residents who utilize a private contractor, the contractor is responsible for the removal of the brush from the property.

Bag Up NJ

The New Jersey Plastic Pollution Reduction Law goes into effect this May. Single use plastic products are one of the greatest threats to our oceans, our environment and our health.

November 4th, 2021 saw the first implementation of this law, with the ban on plastic straws. A food service business may only provide plastic straws to a customer upon the request of the customer.

Beginning May 4, 2022, Food Service businesses, grocery stores, retail stores, restaurants and more are prohibited from selling or providing their customers with single use plastic carry out bags, with sanitary exceptions. (If a grocery store size is above 2500 square feet, paper carryout bags are also banned - if a grocery store size is under 2500 square feet, paper carryout bags are free.) All polystyrene foam food service products are also banned. (with a 2 year extension for long handled spoons, portion cups size 2 oz. or less, meat/fish trays, pre-packaged foods)

How does this new law affect you? What can you do to be prepared? Be a wise consumer. It's good for the future of our planet!

Vote with your wallet- Chose products, businesses, restaurants that are actively working on reducing plastic.

Say YES to Reusable! BRING YOUR OWN BAG!

Going to a restaurant? BRING YOUR OWN TAKE HOME CONTAINERS!

Say NO to plastic utensils/extras when ordering takeout.

Educate your family & friends- Plastic pollution is a public health crisis, climate change and environmental justice issue.

Spread the message of NO littering.

Reduce consumption.

What are the penalties?

Any business violating the bill would get a warning on first offense.

A fine up to \$1000 for a second offense

A fine up to \$5000 for a third or subsequent offense.
