ANNUAL LEAF COLLECTION PROGRAM

The schedule for leaf collection is on-going as follows:

Week of 11/30: Zones 1 & 2

Week of 12/7: Zone 4

Week of 12/14: Zone 5

Week of 12/21: Zone 3



Residents with leaves to dispose of outside of the annual Fall Collection program may bring them to the DPW Yard on Gravelly Hollow Road. Residents who place leaves at the street for collection outside of the Township’s collection program could be cited for violation of Township Ordinance.

Recycling Tip

With the holiday approaching, remember wrapping paper, tissue paper, holiday cards and envelopes, gift boxes, shipping boxes are all recyclable. Please place all these items in your blue recycling cart or you can always take your extra recycling to the Township Yard. Mon- Fri 7am to 2pm and every third Saturday of the month from 8am to 1pm.



HUNTING REMINDER

As we are approaching the State approved hunting seasons, a reminder to residents that per the Township's Administrative Code #109-3 (Parks & Playgrounds), it is prohibited to "hold, posses, or use any firearm or weapon in or within 300 feet of any park, playground or open space area," and "molest, trap, capture or hunt, remove, injure or kill any animal or disturb its habitat, except in portions of any park or open space area designated as open for fishing".

It is also illegal to hunt on private property without licenses issued by the State and express written permission of the property owner. If permission is granted, you must obey all rules of hunting limitations in proximity to residential dwellings and other buildings.
