RECYCLING TIP OF THE MONTH

FREE SHREDDING EVENT, Saturday, October 19, 2019 -- 8:00 am to 12:00 noon at the Municipal Garage, located at 2 Commonwealth Drive. (off of Gravelly Hollow Road behind Bob Meyer Park). This event is for MEDFORD TOWNSHIP RESIDENTS ONLY, ABSOLUTELY NO BUSINESSES WILL BE PERMITTED. Protect yourself and your family from identity theft and financial fraud while taking steps to help the Township's Recycling Program. Residents may bring up to 5 boxes or bags of files (no exceptions) to be shredded on site. An experienced operator will be present with a highly secure, mobile shredding unit where your confidential materials will be shredded as you watch. Please bring paper only; plastic bags, metal, binders and binder clips cannot be shredded. (Paper clips

and staples are acceptable) 100% of the paper is recycled and is applied to Medford's recycling totals, for which we obtain grants from the State of NJ under the Clean Communities Program and Recycling Tonnage Grant. As these dates are the 3rd Saturday of the month, the Garage is also open from 8:00 am till 1:00 pm to accept all other waste and recycling materials.

OPEN SPACE & RECREATION PLAN (OSRP)

On or before December 31, 2019, the Township of Medford intends to submit an "Open Space & Recreation Plan" (OSRP) to the New Jersey Department of Environmental Protection Green Acres Program in order to continue Medford's participation in the Green Acres Planning Incentive Program. Further, this plan will become a part of Medford's Recreation & Open Space element to its Master Plan. Prior to submitting its OSRP Plan, the Township of Medford will conduct two (2) public meetings to receive public comment from residents and other interested parties.

Annual Fall Leaf Collection Program

The 2019 Leaf Collection program will tentatively begin the week of October 28th. The schedule is as follows:

ZONE 3: Weeks of October 28th and November 25th

ZONE 1: Weeks of November 4th and December 2nd

ZONE 2: Weeks of November 4th and December 2nd

ZONE 5: Weeks of November 11th and December 9th

ZONE 4: Weeks of November 18th and December 16th



Residents with leaves to dispose of outside of the annual Fall Collection program may bring them to the DPW Yard on Gravelly Hollow Road. All leaves should be removed from the curbside and disposed of by other means until official notice of the Leaf program is released by the Township. Residents who place leaves at the street for collection outside of the Township's Collection program could be cited for violation of Township Ordinance.

Interesting tidbit from the Environmental Affairs Advisory Committee: Property owners who want to give their lawns a healthy boost should consider putting their rakes away and mulching their leaves this fall. Turfgrass specialists and other researchers have noted the benefits of leaving mulched leaves on a lawn instead of raking them and leaving them for curbside pickup. While researchers noticed an obvious leaf residue on the lawn after mulching, they noted it only stays for a couple of days. Eventually the tiny pieces sift down into the lawn, ultimately serving to control future weed growth while also providing the lawn with essential nutrients. Depending on the type of mower used, up to 6" of leaves can be mulched at a time. Push mowers can only handle a smaller amount, though can still be effective as ride-on mowers. Over time, researchers noted that homeowners who mulched rather than raked their leaves needed less fertilizer to give their lawn a lush, green look in the spring, thus saving the effort, cost and negative environmental impact of fertilizing. Researchers also noted that decomposing pieces of leaves cover up bare spots between turf plants, which have traditionally proven to be excellent spots for weed seeds to germinate. Michigan State University research indicates that homeowners can expect a nearly 100% decrease in dandelions and crabgrass after mulching leaves for just three years!!!!



NEW ORDINANCE

The Township Council has adopted Ordinance #2019 – 12 requiring permits for the placement of dumpsters, roll-off containers, PODS, Bagsters, and other temporary storage containers in streets and roadways in the Township. A MESSAGE FROM THE ZONING OFFICER

Get a Permit Before You Pave.

The Township Land Development Ordinances contain clear guidelines and restrictions for the amount of "impervious" surface one can have on their property. Impervious surface is anything (rooftops, stone or paved driveways, paver patio areas, swimming pools, sidewalks, etc.) that prevents rainwater or melting snow from soaking into the ground. It is against the Township Ordinances to add impervious cover to your property without first obtaining a Zoning Permit.

Why is this important? Much of Medford has high water tables and has been delineated as wetlands and/or wetlands buffers. If property owners are adding impervious cover to their properties, it's preventing rainwater and melting snow from naturally infiltrating or soaking into the ground. The water flows off of properties downhill or downstream where it could potentially create flooding issues for adjacent property owners. The excess stormwater also carries pollutants and sediments into our lakes, streams and other bodies of water where it not only fills in these water bodies, but the runoff also carries fertilizers, pesticides, automotive fluids and animals wastes known to adversely affect the natural surroundings we enjoy in Medford.
