## "What's Up in Medford"

### Deadline to register to vote in the November election is OCTOBER 13<sup>th</sup>

- If you have not voted since 2016 you may need to register again. Check your registration at: https://voter.svrs.nj.gov/registration-check

## Election Day, Tuesday, November 3<sup>rd</sup>. Polls Open 6:00 am – 8:00 pm

- **ONLY VOTERS WITH DISABLITIES** preventing them from voting using a paper ballot will be able to vote on machines at polling location.
- If others go to a polling location they will ONLY be allowed to do a PROVISIONAL PAPER BALLOT.
- All voting for the November 3<sup>rd</sup> election is primarily by Mail—even if you never submitted a request to vote by mail.
- Mail-In Ballots may be returned using the following methods and voters are encouraged to return their completed ballots early:

  - \*Mail ballot by U.S. Postal Service
    \*Drop ballot in the secured Ballot Box located at the Medford Police Building, 91
  - Union Street, Medford, NJ or another ballot Box in Burlington County.
    \*Deliver to the Burlington County Board of Elections, 50 Rancocas Road, 1st Floor,
  - \*Mail-in ballots may also be turned in on the day of election at your respective polling district.

## **HOW TO: Vote By Mail**

- The Board of Elections will begin mailing the ballots out the week of October 5<sup>th</sup>.
- The ballot will come in a large envelope (6 x 10), that <u>may</u> look like junk mail. It will say "OFFICIAL MAIL-IN BALLOT." It will contain 2 envelopes and the ballot.
- Take some time to get acquainted with the materials. There is a Ballot; an "inner" envelope to place the completed ballot, and, a postage paid "outer" envelope to place the "inner" envelope with the ballot.
- Step 1: Complete the Ballot on the FRONT and BACK. USE BLUE or BLACK INK. No pencil. No red ink. Fill in the circle completely. If you make a mistake call the county clerk for a replacement. 609-265-5122. Note: THE BALLOT ITSELF IS NOT SIGNED.
- Step 2: Complete and SIGN the Certificate of Mail-In Voter (CMIV) attached to the "inner" envelope.
- Use your full signature—similar to how you sign formal documents.
- DO NOT detach it. DO NOT tear it off. It has to stay attached as-is.
- If someone helped you, that someone must complete the underside of the envelope
- Step 3: Put the completed ballot inside the "inner" envelope and SEAL THE ENVELOPE—VERY IMPORTANT!
- Step 4: Put the "inner" envelope in the "outer" envelope.
- Step 5: Double check! Depending on the outer envelope design, make sure the return address appears in the window and SEAL THE ENVELOPE
- <u>Step 6:</u> Delivery: (a) Mail it, OR (b) Take it to a DROP BOX Outside the Public Safety Building, 91 Union Street OR, (c) Take it to the Board of Elections **in Mt. Holly OR, (d)** Take it to your polling place on election day. If someone will do this step for you, that someone completes the Bearer portion on the "outer" envelope.
- <u>Deadline is Election Day, Tuesday, November 3<sup>rd</sup>, regardless of delivery method.</u>

## IMPORTANT NOTICE to all Burlington County Property Owners

In 2018 the Alternative Real Property Assessment Calendar (P.L. 2018, c. 94) was signed into law for New Jersey by Governor Murphy. After careful consideration the Alternative Real Property Assessment Calendar was adopted by the Board of Chosen Freeholders of the County of Burlington via Resolution # 2020-00149 on April 9, 2020 to begin implementation as of October 1, 2020.

The assessment calendar change will benefit property owners and municipalities by completing the assessment appeal process before tax bills are generated in 2021 and each year subsequently.

## November 15 – Notification of Assessment Postcards

Property Assessment Notification Postcards for the 2021 tax year will be mailed by November 15 of 2020 and each year thereafter for the following tax year.

\*These postcards were previously mailed on or before February 1 each year.



## January 15 – County Property Assessment Appeal Filing Deadline

The new deadline to file a County appeal of your property assessment will be January 15 each year starting in 2021.

\*This deadline was previously April 1 each year.

On an average assessed value home of \$326,375, the municipal portion of your 2020 property tax bill will be \$1,400.15. The local purpose rate reflects no change from 2019.

The Township Council only has the authority for the Municipal, or Local Purpose and Municipal Open Space tax portions of 0.429, or 13.35% of your pr operty tax bill. Based on \$100.00 per assessed value, your tax dollars look like this:



Although your tax bill is paid to the Township, the remainder of these tax dollars are forwarded to the Medford School Board of Education, the Lenape Regional High School Board of Education and the Burlington County Board of Chosen Freeholders which govern their respective portion of your property tax bill.
