

Saturday, September 17, 2022 from 8:00 am to 12:00 noon

FOR MEDFORD TOWNSHIP RESIDENTS ONLY!!!! NO BUSINESSES WILL BE PERMITTED

Protect yourself and your family from identity theft and financial fraud while taking steps to help the Township's Recycling Program.

The shredding truck will be available from **8:00 am until 12:00 noon** at the Municipal Garage, located at 2 Commonwealth Drive. (off of Gravelly Hollow Road behind Bob Meyer Park)

Residents may bring up to 5 boxes or bags of files (no exceptions) to be shredded on site. An experienced operator will be present in a highly secure, mobile shredding unit where your confidential materials will be shredded as you watch. Please bring paper only; plastic bags, metal, binders and binder clips cannot be shredded. (Paper clips and staples are acceptable)

100% of the paper is recycled and is applied to Medford's recycling totals, for which we obtain grants from the State of NJ under the Clean Communities Program and Recycling Tonnage Grant.

As this date is the 3rd Saturday of the month, the DPW Yard/Garage is also open from 8:00 am till 1:00 pm to accept all other waste and recycling materials.

FROM 500 POUNDS OF PLASTIC TO A TREX BENCH!

Last summer, the Medford Green Team challenged the residents of Medford to collect 500 pounds of discarded plastic in 6 months. What did we do with all of that plastic? We bundled it up, weighed it and took to local retailer that has an affiliation with the TREX company. (The TREX Company hosts collection programs to promote plastic film and bag recycling.) Our local retailer sends all the plastic to their distribution center where it is picked up by a TREX truck and used to make TREX furniture and decking.

What do we get from collecting all that plastic, besides the satisfaction of knowing we have kept 500 pounds of plastic off our roads ,beaches and out of our dumps? A bench made out of TREX material!

Our first bench was placed in Still Park, where you can sit under a shady tree and enjoy the sights and sounds of the park. Still Park is located behind Cranberry Hall, along Filbert Street between Mulberry and Church Streets. The park is dedicated to the memory of Dr. James Still, "The Black Doctor of the Pines". The park has plenty of open space, tot equipment, picnic tables & grills, a rain garden and a Butterfly Garden (sponsored by the Pinelands Garden Club of Medford).

We are currently awaiting delivery of our second bench. (That's right we have collected over 1000 pounds of plastic!) We are continuing to collect plastic for our third bench which will be placed in Freedom Barks Dog Park. Plastic can be dropped off in Medford at Lower Forge Brewery, the Main Street Market (the 2nd and 4th Saturday of the month from 9am—12 noon thru October) and at events sponsored by Freedom Barks.

ANNUAL SUMMER/FALL BRUSH COLLECTION

The Summer/Fall schedule is on schedule as follows:

Zone 4: Week of August 8 Zone 2: Week of August 22 Zone 1: Week of September 5 Zone 3: Week of September 19

Zone 5: Week of October 3



Brush shall include the pruning of trees, shrubs, bushes or vines, but exclude grass clippings, flowers, weeds, tree trunks, stumps, and leaves. If the excluded items are mixed with the brush, the material will not be collected. All brush must be piled neatly at the edge of the property and cannot be placed in any roadway or sidewalk. Brush should not exceed 4-6 feet in length, and should not be any larger than 12 inches in diameter. As a reminder for those residents who utilize a private contractor, the contractor is responsible for the removal of the brush from the property.

JACKSON ROAD BRIDGE UPDATE FROM BURLINGTON COUNTY

Construction work has commenced on the bridge repairs to the Jackson Road bridge. As evidenced by the large crane on site, contractors are currently driving pilings and installing sheathing on the north side of the bridge for the bridge supports. It is anticipated that the south side pilings will be started next week.

The work is very exacting, as they are drilling within 10 feet of major underground power lines.

Once the pilings are completed, PSEG will mobilize on site to relocate their electric power lines.

Upon PSEG completing their phase of the project, contractors will grade the supports and install and weld the bridge panels.

Lake lowering is anticipated during this project.

Barring any unforeseen delays (i.e. weather emergency requiring PSEG to mobilize elsewhere), County officials anticipate the project will be completed before the end of the year.



NEW FLAG RETIREMENT BOX IN TOWN HALL LOBBY

Township officials are most pleased to unveil a new United States flag retirement box, which was an Eagle Scout project undertaken by Nate Kazunas of Medford Boy Scout Troop #20. Nate is pictured here with his parents delivering and placing the wooden, hand constructed box.

This official flag retirement box is located on the first floor in the lobby of the Town Hall Building at 49 Union Street. This box offers a safe and convenient method for residents to properly dispose of U.S. flags that are no longer in suitable condition to be displayed.

According to national laws, US flags should never be discarded in with trash or recycling. Those that need to be "retired" should be destroyed during procedural ceremonies; many times conducted by local VFWs and Scout Troops. This collection box will be monitored by Medford VFW Post 7677 and Medford Boy Scout Troop 20, who both schedule official flag retirement ceremonies several times a year. This retirement box was intended to offer an easily accessible location where residents can bring faded or damaged flags and be assured they will be properly disposed of in an appropriate manner.

NJ IN DROUGHT WATCH STATUS

The NJDEP currently has New Jersey in a drought watch status. (https://dep.nj.gov/drought/) Under a drought watch, their focus is placed on voluntary reductions in demand through increased public awareness. The Commissioner's declaration of a drought watch is the first in the State's three-stage drought advisory system. The watch is intended to sow public awareness and appreciation of the stress upon water supply sources and encourage voluntary water conservation measures. If conditions do not improve, declaration of a drought warning or a drought emergency with mandatory water use restrictions may become necessary. Voluntary conservation measures at the watch stage can help to avoid more serious and restrictive drought conditions.

As a reminder to residents, under Chapter 121-3(K) of the Township's Administrative Code (Water Conservation): for the period May 1 through September 30 of each year, the following water conservation regulations shall be in effect:

- (a) The use of public water for irrigation shall be limited to an odd/even schedule according to date and the users' house number.
- [1] The use of public water for irrigation shall be limited to six hours per day, from 5:00 a.m. to 8:00 a.m. and 5:00 p.m. to 8:00 p.m. prevailing time in accordance with the odd/even schedule as set forth in Stage 1, above.
- 2] Properties equipped with automatic sprinklers, for the purpose of watering lawns, shrubs, trees, flowers or gardens, are permitted to be watered according to the odd/even schedule from 5:00 a.m. to 8:00 a.m. only.
- [3] Swimming pools are permitted to be filled or topped off in accordance with the odd/even schedule set forth in Stage 1 above.
- [4] Flowers and shrubs on properties having hand-held hoses equipped with an automatic shut-off nozzle are permitted to be watered as needed.
- [5] Common areas, which shall be defined as an area within or related to a site, including but not limited to passive or recreation lots, median strips, or open space, intended for the use or enjoyment of residents, may be watered on even dates. common areas shall specifically include (but are not limited to) any property owned and maintained by a homeowners' association.

Township officials appreciate your cooperation as New Jersey remains in a drought watch status.
