II. Review/approve minutes of February 2024 Meeting

Dana Jeffers talked about her new North Main Street business *Love Thy Nature Refillery* that refills various household cleaning and personal care products and accepts recycling and composting bamboo products. Will also be a drop-off site for plastic bag recycling. Opening soon.

 - B. Pelloni said one speaker is lined up for the April 9th program and working on a second. B. Petrillo could do a talk on turtles. B. Pelloni could do a half hour on vermiculture using earthworms. Overall theme is native plants and gardening. Plan for 7pm to 8:30pm plus questions.

- 4. Earth Day & Tree Giveaway Spring Event Sat., April 20th P. Galie will pick up trees from NJ Nursery. The plan is to borrow buckets from her business again. She will be sending around a schedule so we are covered for the entire time from 7:30 to 1 PM at Freedom Park. The goal is to have 2 volunteers at all times. P. Galie & B. Pelloni to set up.

 - a. The township did get the ACE Grant for Phase II Weather Monitoring
 - b. NJDCA Local Rec Improvement. Grant for Canoe Trail. T. Matthews and B. Pelloni will look into getting permits in place from DEP.
- V. Tree City application submitted. 2/25/2024

- VII Trex Bench project status we will now have a fourth collection point. All plastic collected at the EMT Station, Senior Center and Love They Nature Refillery eventually arrives at Lower Forge for weighing before being taken to the recycling center.
- *VIII.* Shade Tree subcommittee Best practices for pruning B. Pelloni, D.Evans, E. Tenthoff, B. Petrillo and P. Galie volunteered to be the subcommittee.

- **8.** Utility Line Tree Cutting Hope to influence guidelines for such trimming. Bo says we should reach out to Government Affairs and Board of Public Utilities.

- 2. Deb asked how can we be more effective in getting the tree ordinance observed. Would it be helpful to send notices to HOA and tree cutting firms and real estate people. Every tree company must be licensed by NJ Board of Tree Experts and must follow town rules. Individuals can file a citizens complaint.

We have a part time Code Enforcement officer on Tuesdays and weekends. Zoning office has a list of all permits for work that includes tree removal.
