NOTICE OF PENDING BOND ORDINANCE AND SUMMARY

PUBLIC NOTICE IS HEREBY GIVEN that the bond ordinance, the summary terms of which are included herein, was duly introduced and passed upon first reading at a regular meeting of the Township Council of the Township of Medford, in the County of Burlington, New Jersey, held on June 9, 2026. It will be further considered for final passage and adoption, after public hearing thereon, at a regular meeting of said Township Council to be held in the Public Safety Building, 91 Union Street, Medford, New Jersey on June 23, 2026 at 6:30 o'clock p.m. During the week prior to and up to and including the date of such meeting, copies of the full ordinance will be made available at no cost and during regular business hours, at the Township Clerk's office in Municipal Building to the members of the general public who shall request the same. The summary of the terms of such bond ordinance follows:

Title: AN ORDINANCE OF THE TOWNSHIP OF MEDFORD, IN THE COUNTY OF BURLINGTON, NEW JERSEY, PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS OF AND FOR THE TOWNSHIP, APPROPRIATING \$3,093,000 THEREFOR, AND AUTHORIZING THE ISSUANCE OF \$2,938,350 IN GENERAL IMPROVEMENT BONDS OR NOTES OF THE TOWNSHIP TO FINANCE THE SAME.

Purpose. 1. Improvements to Township assets and acquisition of vehicles and equipment for the Department of Public Works, including but not limited to acquisition of a fork lift (Toyota Class IV or Equivalent), improvements to fuel system, acquisition of a street sweeper (Elgin Broom Bear or equivalent), replacement of HVAC units at south street and sergeant's office, acquisition of combination sewer truck (Vactor 2100CI or equivalent) and 2026 road improvement program, each as set forth on a list on file in the Office of the Township Clerk, including all work and related materials and equipment necessary therefor and incidental thereto.

Appropriated and Estimated Cost: \$2,063,000.00
Estimated Maximum Amount of Bonds or Notes: \$1,959,850.00

2. Acquisition of equipment for Township Fire Department, including but not limited to SCBA air tank replacements and turnout gear, including all work and related materials and equipment necessary therefor or incidental thereto.

Appropriated and Estimated Cost: \$800,000.00
Estimated Maximum Amount of Bonds or Notes: \$760,000.00

3, Acquisitions of vehicles and equipment for Township Police Department, including but not limited to, forty-five (45) duty handguns with related equipment, patrol equipped SUV (with upfit and required emergency services equipment for police department operations, together with and including customization and related equipment to allow the vehicles to be used for their intended use) and two (2) radar units for patrol, including all work and related materials and equipment necessary thereof or incidental thereto.

Estimated Maximum Amount of Bonds or Notes	\$194,750.00

4. Acquisition of equipment for Township Hall, including but not limited to, acquisition and installation of server/printer for administrative offices, as set forth in a list on file in the office of the Township Clerk, including all work and related materials and equipment necessary therefor or incidental thereto.
