**NOTICE OF PENDING BOND ORDINANCE AND SUMMARY**

PUBLIC NOTICE IS HEREBY GIVEN that the bond ordinance, the summary terms of which are included herein, was duly introduced and passed upon first reading at a regular meeting of the Township Council of the Township of Medford, in the County of Burlington, New Jersey, held on June 9, 2026. It will be further considered for final passage and adoption, after public hearing thereon, at a regular meeting of said Township Council to be held in the Public Safety Building, 91 Union Street, Medford, New Jersey on June 23, 2026 at 6:30 o'clock p.m. During the week prior to and up to and including the date of such meeting, copies of the full ordinance will be made available at no cost and during regular business hours, at the Township Clerk's office in Municipal Building to the members of the general public who shall request the same. The summary of the terms of such bond ordinance follows:

Title:           AN ORDINANCE OF THE TOWNSHIP OF MEDFORD, IN THE COUNTY OF BURLINGTON, NEW JERSEY, PROVIDING FOR VARIOUS WATER/SEWER UTILITY IMPROVEMENTS AND RELATED EXPENSES IN AND FOR THE TOWNSHIP, APPROPRIATING \$4,875,000 THEREFORE, AND AUTHORIZING THE ISSUANCE OF \$4,875,000 IN WATER/SEWER UTILITY BONDS OR NOTES OF THE TOWNSHIP TO FINANCE THE SAME.

Purpose:        1.       Facility improvements to the Township's water and sewer utility systems, including but not limited to improvements to the Township's Sewer Plant consisting of repairs and replacement to Grinder, Sludge Pumps and RBC Bearings, rehabilitation of wells 3, 6 14, 15, 16 and 17, replacement of lead service lines, Slip Lining to existing sanitary sewer lines, replacement of water meters, upgrade of existing Water Main and targeted replacement of infrastructure in coordination with Township's 2026 road program, each as set forth in a list on file in the office of the Township Clerk, including all work and related materials and equipment necessary therefor and incidental thereto.
